

In relation to our letter dated December 11, 2020, we wish to advise the Commission that on December 29, 2020, the Insurance Commission approved the acquisition by Allied Bankers Insurance Corporation (ABIC) of PNB General Insurers Co., Inc. (PNB Gen).

PNB Gen is 65.75% and 34.25% owned by PNB and PNB Holdings Corporation (PNBHC), respectively.

Further, on December 29, 2020, the Share Purchase Agreement by and among PNB, PNBHC and ABIC was signed. Also, on said date, PNBHC received ABIC's payment for the former's shareholdings in PNB Gen.
