As previously disclosed, the Bank exchanged three (3) prime properties with a market value of P46.677 Billion determined by a reliable independent source for equivalent value in shares of stock of PNB Holdings Corporation ("PHC"). With the property dividends declared by the Bank, the Bank's ownership in PHC has been reduced to 49%.

Upon the foregoing, we wish to advise the Commission that the Bank will record approximately P34 Billion in its books reflecting the fair value change of assets from the above-mentioned exchange of properties for shares, thereby further improving the Bank's financial position in these challenging times.
