

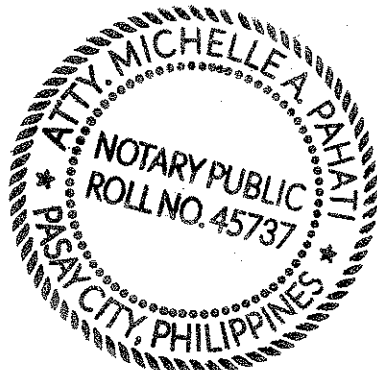


The infusion of additional capital will increase the Bank's shareholdings in PNB-Mizuho Leasing and Finance Corporation from 75% to 83.5%.


